BOROUGH OF GARWOOD COUNTY OF UNION EMERGENCY PROCLAMATION

TO ALL CITIZENS AND PERSONS WITHIN THE BOROUGH OF GARWOOD IN THE COUNTY OF UNION, NEW JERSEY, AND TO ALL DEPARTMENTS, DIVISIONS, AND BUREAUS OF COUNTY AND MUNICIPAL GOVERNMENTS OF UNION COUNTY, NEW JERSEY,

WHEREAS, pursuant to the powers vested in us by Chapter 251 of the Laws of 1942, as amended and supplemented by N.J.S.A. APP 9-30 et. Seq. And N.J.S.A. 2C:33-1 et seq., we have declared that a local disaster emergency exists within the Borough of Garwood in the County of Union; and

WHEREAS, the aforesaid laws authorized the promulgation of such orders, rules, and regulations as are necessary to meet the various problems which have, or may be, presented by such emergency; and

WHEREAS, by reason of Hurricane Sandy threatening to be a major storm with potential for power failure, flooding, tree falling and other catastrophic danger to the safety of the public; and

WHEREAS, it has been determined that the Borough of Garwood should then be declared disaster areas, and further, that certain measures must be taken in order to insure that the authorities will be unhampered in their efforts to maintain law and order as well as an orderly flow of traffic, and further, in order to protect the persons and property of the residents affected by the conditions; and

WHEREAS, the entire Borough of Garwood in the County of Union is designated an emergency area

NOW, THEREFORE, IN ACCORDANCE WITH the aforesaid laws, we do hereby promulgate and declare the following regulations shall be operative effective immediately in addition to all other laws of the State of New Jersey and County of Union and Borough of Garwood;

- 1. <u>All non-essential motor vehicle traffic is prohibited from local roads and streets in order to facilitate all necessary safety measures.</u>
- 2. <u>Curfew: All non essential pedestrian movement throughout the Borough from 21:00hrs (9:00pm) October 29, 2012 for the duration of the storm to prevent injuries, rescues and criminal activity.</u>
- 3. <u>Parked vehicles: May be towed if deemed necessary by The Garwood Police Department.</u>

 <u>Every attempt will be made to make notification prior to tow.</u>
